<b>Venue</b>	Rainier Community Center, 4600 38th Avenue South, Seattle, WA 98118 • (206) 386-1919. Venue will be opened by 8:00 AM on both Saturday and Sunday.
<b>Entry Deadline</b>	Entries must be postmarked by <b>Friday, July 13th, 2012</b> . Entries after the deadline or without full payment <b><u>will NOT be accepted.</u></b>
<b>Refunds</b>	No refunds after entry deadline.
<b>Ratings</b>	For event eligibility, the 06/30 USATT web site published ratings will be used. Seeding will be based on most current ratings.
<b>Policies</b>	Players may not enter two events with same start times. Also, players participating in Team Competition may not enter any other event on Saturday. For unrated players, initial rating will be estimated by the Tournament Committee.  Events can be cancelled or combined at the discretion of the tournament committee. Events with insufficient entries may be cancelled and refunds issued.  No prizes will be awarded for splits, dumps, default losses or no-shows. Play will be conducted under ITTF rules. USATT dress code will be enforced. All decisions of the referee are final.

#### **+Fee:**

- Team competition: Top 3 players average rating under 2250 Fee = \$250; under 1950 Fee = \$200
- Open Single: Player under 2100 Fee = \$60; under 1900 Fee = \$40; under 1700 Fee = \$20
- Under 2500: Player under 2100 Fee = \$30; under 1700 Fee = \$20
- Under 2350: Player under 2100 Fee = \$30; under 1700 Fee = \$20
- Under 2150: Player under 1700 Fee = \$20
- Under 1950: Player under 1600 Fee = \$20
- Under 1750: Player under 1500 Fee = \$20

**NOTE:** Players who receive **\$600** or more must fill out Form W-9 (Request for Social Security or Employer ID number).

#### **Open Singles Semi and Final Schedules (Sunday, July 29, 2012):**

- Semifinals: 3:00 PM.
- Final: 4:30 PM.

All matches will be best of 5 games to 11 points, except the Open Singles final, which will be best of 7 games.

All players **MUST** check-in at least **30 minutes** prior to their first match play.

- Maximum 32 teams.
- Minimum 3 players and maximum 5 players per team.
- Team seeding is based on average rating of the top 3 players.
- Each team will play **five** rounds if fully enrolled.
- Each round is best of 5 matches.
- A team match shall consist of 3 players per team.
- The order of play shall be: **A v X, B v Y, C v Z, A v Y, B v X.**

- First Round:** SE to determine top and bottom 16.  
**Second Round:** SE to determine top 8, 2<sup>nd</sup> 8, 3<sup>rd</sup> 8, and bottom 8.  
**Third Round:** SE to determine top 4, 2<sup>nd</sup> 4, 3<sup>rd</sup> 4, ....., bottom 4.  
**Fourth Round:** SE to determine top 2, 2<sup>nd</sup> 2, 3<sup>rd</sup> 2, ....., bottom 2.  
**Final Round:** Finals to determine 1 to 32 places.
