Check-in: Players should check-in as early as possible and should arrive **NO LATER** than 30 minutes prior to the starting time for their earliest event. (Note: The venue opens at 9:00am).

Format:

- Minimum 4 Teams & Maximum 12 teams for each event.
- Minimum 2 players and maximum 3 players per team.
- Team seeding is based on the rating sum of the top 2 players.
- First round will be Round Robin and Subsequent rounds will be single elimination.
(Top Team from each group in the first round will advance to the next round)
- Each round is best of 5 matches.
- A team match shall consist of 2 or 3 players per team.
- The order of play shall be: **A v Y, B v X, Doubles, B v Y, A v X.**

Event: Player may be removed from an event at any time should the Tournament Committee decide that the player is overqualified. The Tournament Committee also reserves the right to cancel any event if there are insufficient entries. Fees will be refunded for any cancelled events.

Equipment: Only USATT approved equipment will be used; Butterfly tables and white Butterfly 3-Star balls will be used.

Ratings: For event eligibility, the 03/25/2013 USATT web site published ratings will be used. Seeding will be based on most current ratings.
