- U-4200 Doubles required at least 4 teams registered
- All matches are 11 points best of 5 games, except for the final match of Open Singles, which will be best of 7 games if players request.
- USATT rules and regulations will be enforced.
- **Event**: Player may be removed from an event at any time should the Tournament Committee decide that the player is overqualified. The Tournament Committee also reserves the right to cancel any event if there are insufficient entries. Fees will be refunded for any cancelled events.
- **Equipment**: Only USATT approved equipment will be used; STIGA tables and white Nittaku three star 40+ Balls will be used.
- **Ratings:** For event eligibility, the 03/15/2015 USATT web site published ratings will be used. Seeding will be based on most current ratings.
